

# Richmond DPU: City Improvement Projects

**Job:** Lake Cherokee Dam Rehabilitation Project

**Location:** Cherokee Road between Croatan Road and Cheyenne Road

## Project Introduction

Cherokee Dam is a small impounding structure which creates Lake Cherokee in Richmond's Huguenot neighborhood. Cherokee Dam is owned by the Lake Cherokee Association, residents who own property on the dam, and the City of Richmond.

The Lake Cherokee Dam Rehabilitation Project has been initiated to ensure that Cherokee Dam is in compliance with Virginia Department of Conservation and Recreation dam safety regulations. Collaboration and coordination efforts are ongoing between all Cherokee Dam owners as a strong partnership will be vital to ensuring a successful project and that dam safety regulatory requirements are met.

## Field Investigations:

Residents may see field personnel, survey crews, and vehicles within the project area collecting data and performing field investigations.

## Public Meetings:

Discussions with property owners and Lake Cherokee Association members have been ongoing.

A virtual meeting was held with the Lake Cherokee Association and Lake Cherokee property owners on Wednesday, November 15th at 6:30 pm via Microsoft Teams to discuss the proposed improvements and receive feedback.

It is anticipated the next meeting will be held in the Spring of 2024, though conversations continue in the interim and the project team is always happy to connect with residents. Please do not hesitate to reach out.

The times and locations of future collaborative meetings will be announced as the project progresses.

## Project Duration:

Phase 1 rehabilitation activities, including vegetation removal, have been completed.

Phase 2 rehabilitation design is underway for the Lake Cherokee Dam Rehabilitation Project.

Due to the scope of work needed to meet dam safety regulatory requirements and complete the Lake Cherokee Dam Rehabilitation Project, a preliminary estimate is that construction may take up to two years.
